









Aleutians West claimants by age group







When Anchorage claimants received their first payment





Anchorage claimants by age group

















Fairbanks claimants by age group













Juneau claimants by age group







Kenai claimants by age group







Lake & Peninsula and Bristol Bay claimants by age group









Mat-Su claimants by age group



















Prince of Wales-Hyder claimants by age group







Sitka claimants by age group














