- Transportation-Gommunication-Public Utilities: Estimated employment in transportation-communication-public utilities for January 1962 was 7,200 jobs, with no over-all change from December 1961, but an increase of 600 over the number of jobs reported for January 1961. Month-to-month and year-to-year variations were slight except in the communications industry, which has increased with the completion of the defense warning systems and other communications advances. Trucking-warehousing, water transportation, and air transportation each had an increase of 100 jobs over last year's employment level.
- Wholesale-Retail Trade: The January 1962 employment estimate for total trade was 7,800 jobs, down 400 from last month, but 300 higher than January 1961. There was a post-holiday drop in both wholesale and retail trade totaling 400 jobs. Wholesale trade, food stores, and eating and drinking places fell off 100 each, and general merchandise 200 jobs, all reflecting seasonality. In spite of month-to-month drops, food stores, and eating and drinking places each had 200 worker increases over mid-January of last year.
- Finance-Insurance-Real Estate: The January 1962 employment level for finance-insurance-real estate was estimated to be 1,600, remaining the same as last month, but above January 1961 by 100 jobs, the year-to-year growth occurring in the banking and finance industry.
- Service & Miscellaneous: Employment in the service industries for January 1962 was estimated to be 5,700, an increase of 100 jobs over the previous month and of 700 jobs over the January 1961 employment level. The year-to-year growth occurred chiefly in medical services, business services such as advertising and automotive repair, and a small increase in the hotel and lodging industry.
- Government: The total government employment estimate for January 1962 was 22,400 jobs. This was a decline of 100 from December 1961, and also 700 lower than January 1961. The seasonal month-to-month downward movement occurred in Federal defense jobs. Although there was a year-to-year increase in local government employment, deactivation and job reductions in Federal defense agencies resulted in lower level of government employment this year than last.

## HOURS AND EARNINGS

Average weekly earnings in Alaska industries, based on the mid-January estimate, show an increase from last month in all major industry groups except construction, and finance-insurance-real estate, both of these being based on shorter work-weeks. Reduction in average weekly hours also was the chief contributing factor to a lower year-to-year earnings figure in construction, wholesale trade, and finance-insurance-real estate. The average hourly earnings all were above the previous month and the current month a year ago except a drop from last year in construction due mainly to a reduction of overtime hours.
